### STATE OF WISCONSIN BROKER DISCLOSURE

#### *To Non-Residential Customers Wisconsin*

*Law requires all real estate licensees to give the following information about brokerage services to prospective customers.*

- *The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information of other parties.*
- *The duty to safeguard trust funds and other property the broker holds.*
- *The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.*

This disclosure is required by section 452.135 of the Wisconsin Statutes and is for information only.
